A non-refundable Bid Fee of One Hundred Pesos (Php 100.00) shall be paid to the COA Region VII Cashier. Upon payment of the bid fee, the interested buyers may secure the Bid Form from Marissa A. Gutierrez, Secretariat, Regional Disposal Committee at the Admin., Training & Finance Services, COA Regional Office No. VII, Cebu City.

The sealed bid/offer must be delivered on or before 12:00 Noon, May 14, 2019 at the Library, 2nd Floor, COA Region VII Main Building, M.J. Cuenco Avenue cor V. Sotto Street, Cebu City. All bids must be accompanied by a bidders bond in the amount stated in No. 6 of the Terms and Conditions.

Opening of sealed bids shall be held on May 14, 2019, 2:30 P.M. at the Library, 2nd Floor, COA Region VII Main Building, M.J. Cuenco Avenue cor V. Sotto Street, Cebu City in the presence of the bidders or their duly authorized representatives.


