

CONTRACT AGREEMENT

THIS AGREEMENT FOR THE SUPPLY AND DELIVERY OF ICT EQUIPMENT (IB NO. G-2022-02) made and entered into this 27th day of May 2022 between the **COMMISSION ON AUDIT (COA)**, Regional Office No. VIII, Leyte Government Center, Candahug, Palo, Leyte (hereinafter called the **"Entity"**) of the one part and represented in this transaction by its Officer-in-Charge, **Atty. ARNEL T. JARANILLA**, who is duly authorized to represent the Commission; and **HANDLINK INC.**, of Unit 421, Krizia Bldg., Gorordo Avenue, Lahug, 6000 Cebu City (hereinafter called the **"Supplier"**) of the other part and represented in this transaction by its Account Manager, **Mr. AL-GAFRI L. HASHIM**:

WHEREAS, the **Entity** invited Bids for the Supply and Delivery of ICT Equipment for COA Regional Office No. VIII and has accepted a Bid by the **Supplier** for the supply and delivery of ICT Equipment in the sum of **Five Million One Hundred Ninety-Three Thousand Eight Hundred Pesos (P5,193,800.00)** (hereinafter called the **"Contract Price"**).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
