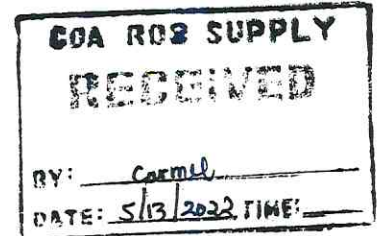

BIDS AND AWARDS COMMITTEE

RESOLUTION NO. 2022-046
Series of 2022

WHEREAS, the Commission on Audit through its Bids and Awards Committee (BAC), published an Invitation to Bid on March 17, 2022 to April 8, 2022 for the Supply and Delivery of ICT Equipment (IB No. G-2022-02) with a total Approved Budget for the Contract (ABC) of **Five Million Four Hundred Sixty-Seven Thousand One Hundred Eighty-Five Pesos (P5,467,185.00)** under Purchase Request (PR) No. 2022-02-0075 dated February 28, 2022;

WHEREAS, in response to the said advertisement, two (2) bidders, namely: Joebz Computer Sales and Services (Joebz); and Handlink, Inc., purchased the Bidding Documents;

WHEREAS, both bidders submitted their bids before the deadline on April 8, 2022, and during the opening of bids, both bidders passed the preliminary examination of the technical and financial components of their bids;

WHEREAS, the financial bids of Joebz and Handlink are as follows:

Bidder	ABC	Bid Amount (As Read)
Joebz	P5,467,185.00	P5,136,500.00
Handlink		P5,193,800.00

WHEREAS, the Report on Detailed Bid Evaluation dated April 8, 2022 submitted by the Technical Working Group (TWG) on the same day, showed that the bid of Joebz was unresponsive while the bid of Handlink was responsive with a Calculated Bid of P5,193,800.00;

WHEREAS, after the deliberation by the BAC on the Report on Detailed Bid Evaluation of the TWG, the bid of Handlink was declared as the Single Calculated Bid;

WHEREAS, the bid of Handlink underwent post-qualification by the TWG wherein the Post Qualification Report submitted to the BAC on April 29, 2022 disclosed that the bid was responsive in all the requirements specified in the Bidding Documents;

WHEREAS, the Post Qualification Report of the TWG was deliberated upon by the BAC on May 10, 2022, after which Handlink was declared as the Single Calculated and Responsive Bid;

WHEREAS, Section 36 of the 2016 Revised IRR of Republic Act No. 9184 provides that a Single Calculated and Responsive Bid shall be considered for award if it falls under any of the following circumstances:

- a) xxx;
- b) If after advertisement, more than one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; or
- c) xxx;

NOW THEREFORE, the Bids and Awards Committee **RESOLVES** as it does hereby **RESOLVE**;

To recommend to the Head of the Procuring Entity the award of contract for the Supply and Delivery of ICT Equipment involving an amount not exceeding **Five Million One Hundred Ninety-Three Thousand Eight Hundred Pesos (P5,193,800.00)**.

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Head of the Procuring Entity, the Officer-in-Charge, COA Regional Office No. VIII, Candahug, Palo, Leyte, which shall be made an integral part of the procurement documents.
